What personal data do we collect about you? How will we use that personal data?

When you are an award recipient, we will process your personal data. From your application form, we will collect and process your name, academic status, email, phone number and bank details. We need this information in order to assess your application. Your bank details are required in order to grant you the amount of the award.

From the grant agreement, we will process your name, photo and academic/professional aspirations. This information is required for publicity purposes and for our annual reports and accounts. This is a contractual requirement and you cannot receive an award if you do not provide this information.

What is our legal basis for processing your personal data? How long do we hold your personal data?

We need a legal basis in order to process your personal data. Our processing is because we have a contract with you (grant agreement). We will hold your name, academic status, email and phone number indefinitely for the grants system. Your bank details will be deleted once the award funds have been transferred to you.

Your name, photo and academic/professional aspirations will be held until they are no longer needed for publicity purposes, after which they will be destroyed.

If your application is not successful, we will hold it indefinitely as we have a legitimate interest in knowing who has applied for our awards in the past.

Do we use any automated decision making?

We do not use any automated decision making.

Who do we share your personal data with?

We share your personal data with the following recipients:

Do we transfer your personal data outside of the EU or EEA?

We do not transfer your personal data outside of the EU.

Your rights

You have rights in respect of our processing of your personal data which are:
